Training Programme Overview

This combined, interactive and practical full one or two days' programme is run in Brussels, at the heart of EU institutions. It is in a form of workshops and includes introduction and half day visits to selected EU institutions. The actual fact finding speeches are given by selected MEPs (also according to the wishes from the participants), Commission Officials from interesting DGs, representatives (based in Brussels) of advanced and successful regions, etc. experts having in-depth understanding of EU, its directions and actions to the future.

The subjects themes vary from the high level EU constitutional, enlargement and other issues to Europe's global future role throughout the consequences of some actual specific topics or proposal directives under discussion, to the issues of the role of EU's Information Society activities and technologies, strategies to establish a European Knowledge Society taking advantage of efficient, interoperable eAdministration facilities providing eServices for citizens and business communities.

The programme consists of visits to European institutions, e.g. the Parliament, the Committee of the Regions (CoR) and/or Economic and Social Committee, the Commission. The programme is flexible and each training programme can be partly tailor-made to include actual hot EU topics, participants' proposals and interests to defined subject areas that you would like to learn about in depth in Brussels from persons in spot.

Our programmes can also be fully tailor-made and they can constitute an additional module or supplement to visit programmes organised by e.g. the regional offices in Brussels. Do not hesitate to ask for more details!
